

MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (“MOU”) is entered into this 17th day of December, by and between the Jackson Health System/Public Health Trust (“JHS”), and the Service Employees International Union, Local 1991 (“SEIU”), collectively referred to as the “Parties”.

WHEREAS, the Parties agree that because of the demands of the market during this unprecedented crisis, the Public Health Trust (“PHT”) has taken necessary steps to attract and retain highly competent and experienced per diem clinical staff nurses to combat the COVID-19,

NOW THEREFORE, Parties hereby agree that the following actions taken by JHS are acceptable.

- Crisis Period Shift Pay Program:** In an effort to recruit experienced per diem clinical staff nurses to care for COVID-19 patients, PHT will implement a Crisis Period Shift Pay Program to allow the Trust to compensate eligible per diem clinical staff nurses for working a certain number of shifts.
- Per diem clinical staff nurses who are recognized as bargaining unit members of the SEIU RN Collective Bargaining Agreement (per diem employees who average 20 or more hours weekly) will be eligible for this pay as delineated below:

- Per diem nurses who work at the Behavioral Health, Primary Care Center (PCC), the Ambulatory Care Center *(ACC), Urgent Care Center (UCC) and Rehab will not be eligible for this shift pay program.

4. This shift pay is being paid at the end of each pay period and all shift differentials will apply. This program will take effect immediately and the PHT agrees to provide the Union with a minimum of 24 hours' notice of its intention to stop the Crisis Shift Pay Program for per diem clinical staff nurses.
5. This MOU will supersede the MOU entered into with SEIU regarding the Crisis Period Shift Pay Program on August 14 2020.
