RE: Tiered Per Diem Rates

Dear Ms. Baker,

This Agreement is entered into this 28 day of June, 2022 by and between the Jackson Health System/Public Health Trust of Miami-Dade County (the "JHS") and the Service Employees International Union, Local 1991 ("SEIU").

WHEREAS, the parties agree that because of the demands of the market, the Public Health Trust must take necessary steps to attract and retain clinical staff;

NOW THEREFORE, in consideration of the mutual covenants contained herein, the Parties hereby agree to voluntarily enter into this MOU, which contains the following agreements and stipulations:

1. **Crisis Period Shift Pay Program:** In an effort to recruit experienced per diem clinical staff nurses, PHT will continue to implement Crisis Period Shift Enhancement Pay Program to allow the Trust to compensate eligible per diem clinical staff nurses for working a certain number of shifts.
2. Effective July 10, 2022, Per diem clinical staff nurses who are recognized as bargaining unit members of the SEIU RN Collective Bargaining Agreement (per diem employees who average 20 or more hours weekly) will be eligible for this pay as delineated below:

3. This shift pay will apply to all inpatient per diem clinical staff nurses caring for patients.
4. This shift pay is being paid at the end of each pay period and all differentials will apply. This program has taken effect and will continue until the crisis is lifted
5. The Parties agree that this is a one-time non-precedent setting agreement, that no promise, inducement or agreement not expressly contained herein has been made, that this MOU contains the entire agreement between the Parties hereto, and that the terms of the MOU are contractual and not a mere recital.
